A. By Law Changes

2. Revise By-Law Article XI and ask that all clubs pay prior to or at the fall meeting. Eliminate the grace period. – Diane Redman

3. Amend the WSCA By-Law to formally adopt Roberts Rules of Order as framework for our meetings. – Rich Nemitz

4. Changes to By-Laws involving All State Team and Hall of Fame points awarded for being on All State Team. – Paula Benbow
