Women's Hall of Fame Category Nomination Criteria

- Must have accumulated a minimum of 1000 points, as defined below, to qualify for the Women's Category for the WSCA Hall of Fame. *
- Must have been a member of the NSCA for at least 10 years.
- Must have attained a minimum age of 40 years.
- Must be a Wisconsin resident during the accumulation of points for WHOF Category eligibility.
- Grandfather rule if a shooter moves out of state, then subsequently moves back in state. Out-of-State Women's Concurrent 1st and Open Team Memberships garnered during that interim out of state residency period would count towards WHOF points based on Wisconsin WHOF points, with a total limit on points earned from out of state teams at 300 points.
- HOF Nomination Committee can award extra service points for any outstanding service by a shooter or officer.
- If a Woman shooter qualifies and is inducted into the Women's HOF Category and subsequently qualifies and is inducted to the Open HOF, that shooter will be removed from the WHOF Category and elevated with full recognition to the WSCA Open HOF.
- The existing Open HOF Chairman and Committee will select Women's HOF Category nominees to be presented to the WSCA Board for final selection.
- Women's HOF Category inductees shall be displayed on a page that is separate from the Open HOF on the WSCA website.
- Points accrued from the existing Open HOF point Values may be applied to the aggregate total accumulation of points required for the Women's HOF Category eligibility, but accumulated Lady Concurrent category points may ONLY be applied to the eligibility point total for the Women's HOF Category.

Women's Hall of Fame Category Nomination Committee

- Chairman: Bruce Ramos
- Chairman of the HOF Committee is to be appointed by the WSCA Board. All inductees shall become life members of this committee.
- Chairman can appoint additional members to the Hall of Fame Committee.
- HOF Nomination Committee shall present WHOF nominees to the WSCA Board at Spring Meeting. The WSCA Board shall pick inductees to WHOF.
- WHOF category inductees will become members of the selection committee ONLY for the purpose of review and selection of other candidates for the Women's HOF category.

Resident 12ga State Champion	100
Resident 12ga State Runner Up	50
Iron Man HOA (if more then 150 shooters)	100 ***
Iron Man Runner Up	50 ***
Open Champion - Events (12ga within state) with 150 entries or more	100 ***
Service as an Officer of the WSCA Board (shooters only, limited to a life time maximum of 125 points)	25/yr
Resident Lady Concurrent WI State Champion	75**
Resident Lady Concurrent WI State Champion Runner Up	50**
WSCA All State Team-First Team Lady Concurrent	50**

* Accumulation of 1,000 points only makes a shooter eligible to be considered for nomination/election to the Women's HOF Category and does not guarantee election, nomination or automatic inclusion in the Women's HOF Category.

** Lady Concurrent points ONLY accumulate to total for eligibility for the Women's HOF Category and cannot be applied to the Open HOF eligibility.

*** No more than 200 points per calendar year may be garnered from the Iron Man HOA, Iron Man Runner Up and/or the individual events that comprise the total Iron Man event.
